- Correspondence exchanged with planning applicant seeking clarity of North Nibley Parish Council's response on Stroud District Council website
- Newsletter on proposed planning changes has been shared with Parish Council

- Parishioner has raised concern to Councillor Harper over "lack" of grass cutting on certain areas around children's play area by Village hall, especially the area around the notice board. Clerk reported to District Councillor Braun who has escalated to the Tenants Services team for information.

- Another member of the public has raised concerns to Councillor Harper about the (hedge/trees/garden) growing on to the path way by the T& Cakes. This is the

ongoing issue that the Parish Council has reported to Stroud District Council and highlighted to District Councillor.
