# North Nibley Biodiversity Discussion 23/10/24

## What (might we consider doing)?

- Mow Knoll and remove grass
- Swift Boxes
- River Monitoring
- Map areas that can be managed differently
- Ensure proposed new play area is combined with conservation initiatives and any removed trees at least replaced
- Re-survey the Knoll around May/June (Bel/Aileen to lead?)
- Wildflower planting in odd corners of village
- Co-ordinate Butterfly Count to coincide with National Survey
- Tyndale Monument flood lighting possibly detrimental to wildlife? Could the lights be switched off in the Spring/Summer?
- Community Engagement ideas:-
  - Collate RSPB birdwatch results for Nibley
  - Record butterfly and hedgehog sightings
  - Adopt a Verge
  - o Adapt swift box model success with bug hotels, hedgehog friendly gardens etc
  - o Regular page in OTE
- Create Hedgerow friendly gardens
- Hedgehogs road speed!
- Greenway to Wotton
- Invite subject matter experts to give talks relevant to local biodiversity
- We need to make a wetland somewhere
- Village Pond?
- Create Biodiversity Action Plan
- Glow Worm Survey
- Butterfly Survey
- Consider Community Asset Transfer for areas that could be managed differently. But NB liability and might be better to influence current regime rather than take on full responsibility/liability
- Set up Volunteer Group to take action on planting, cutting back, mow and collect
- Pond Restoration Scheme
- Protect Skylarks on Knoll consider temporarily fencing off nesting sites at certain times?
  Discussion about whether this is practical and desirable vs open access
- NN School Housemartin population
- Need to have prioritised action so success is achieved in a few areas first suggested that Churchyard and Roadside verges are a good place to start.
- Information Board at Knoll for benefit of land and monument if it can be grant funded
- Education needed for residents on small scale actions that can be taken, e.g. Hedgehogs and Wildflowers

## Where (might we do it)?

- The Knoll co-operation between Parish Council, Knoll Trust and Monument Trust future Grant opportunities
- Verges/odd corners etc influence current managers need to establish who is currently responsible – Gloucestershire Highways or Stroud District Council
- e.g. banks outside Swedish Houses, triangle at Southend, area under Jubilee Tree (but this is possibly already being managed to benefit biodiversity due to Alan Kennett's intervention?)

- Churchyard review current management regime and research Eco-Church scheme <a href="https://www.ecochurch.arocha.org.uk">www.ecochurch.arocha.org.uk</a>. Church are keen to have a management day so this could be first of an environmental volunteer session in the Spring?
- Hedgehogs consider way of reporting sightings and educate residents on how to develop habitats/make gardens more hedgehog friendly
